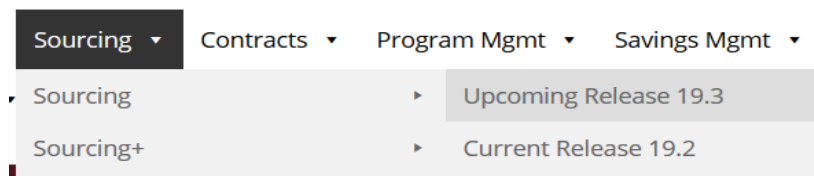
# Welcome

The **21.1 JAGGAER One Product Release** will be available in the production environment starting April 12, 2021. The purpose of Release Notes is to prepare administrators for the upcoming release from an application standpoint.

# General Enhancements

## Splittable/Non-Splittable Parent-Child Custom Fields Allowed as Code Favorites and Applicable to Documents

With the 20.3 release, buyers were given the ability to configure parent-child relationships between non-splittable custom fields as well as between non-splittable fields and splittable fields. As part of this feature, additional flexibility was given to placement of parent and child fields on a document as well. However, if a code is configured in a **non-splittable parent / splittable child** relationship, it could not be added as a **Code Favorite** in the user profile. This feature also affected a user's ability to use Code Favorites on documents in the solution.

With the 21.1 release, codes that are in a **non-splittable parent / splittable child** relationship can be added to a user's **Code Favorites**. As a result, users now have the ability to use these **Code Favorites** as code defaults on requisitions and invoices. Along with this feature, a hierarchy has been introduced for applying Code Favorites to documents, such as invoices created from Contracts and Non-PO Invoices.

### User Impact

- If a code is configured in a **non-splittable parent / splittable child** relationship, it can be added as a **Code Favorite** in the user profile to set default values (**User Profile > Default User Settings > Custom Field and Accounting Code Defaults > Code Favorites**).
  - There is no change how users select from Code Favorites within a document. The applicable child fields will become available when the parent is selected, regardless of group placement.
- If a **Code Favorite** includes a **non-splittable parent / splittable child** relationship and is flagged as Default in the user profile, it can now be used in populating new transactions including requisitions and invoices according to the following hierarchy:
  - If an invoice is being created **from a contract** with "Code Defaults on Invoice" values (Contracts > Search Contracts > [selected contract] > eProcurement Setup page), the contract codes will be applied first.
  - If the user is creating a **non-po invoice NOT associated with a contract**, configured Non-PO Code Rules will be applied (Accounts Payable > AP Administration > Manage Non-

PO Code Rules).

- If neither of those conditions apply to the invoice, the **User Profile Code Favorites Defaults** will be applied.

## Administrator Impact

- The **User Import** process has been updated to allow for parent-child splittable/non-splittable combinations when importing custom field values. process (**Administer**  **> Manage Users > Import Users From a File**)
  - When providing code favorites information, the Values column must include the Parent value with each child in the **Values** string:

- In the example above, **Region** and **Company** are the non-splittable parent fields, and **Cost Center** and **Account** are the splittable children. Note that the Parent name and values are listed for each row. All related field names must be included for each row, even if the related fields are in different document groups.
- An error message will display for the row if the prerequisite parent is not included on the row for the child custom fields.
- When Exporting a user or list of users in **Advanced, Tab Delimited** format, the **...CodeFavoritesExport** file in the .zip archive contains the configured Parent value at the beginning of each Code Values string, as displayed above. This was existing behavior for splittable parent-child relationships, and has now been extended to non-splittable parents.

# Supplier Profile - New Mobile Number Field for Supplier Contacts

With the 21.1 release, users have the ability to enter a **Mobile Phone Number** for supplier Contacts. This Mobile Number can be used for two-factor authentication with Contracts+ (see **Support for DocuSign Advanced Electronic Signatures** in the 21.1 Contracts+ Release Notes). For Supplier Management customers, the field can be configured in the Supplier Registration profile form (see **Ability to Require Supplier Contact Mobile Number in Supplier Registration** in the 21.1 Supplier Management Release Notes).

## User Impact

- Users can include a **Mobile Phone** for a supplier contact.
- Navigate to a supplier profile (**Suppliers**  **> Manage Suppliers > Search for a Supplier > [selected supplier] > Contacts and Locations > Contacts** page)
  - Select a contact from the list, or click to **Add a Contact**.
  - Note the **Mobile Number** field available under the Phone field.

## Administrator Impact

## Third-Party Integration Impact

- The **Supplier XML Export** and **Supplier Import** have been updated to include **Mobile Phone Number** field. Contact JAGGAER for details.

## Supplier Impact

- Suppliers will see the **Mobile Phone Number** field when managing or adding a **Contact** in the **Supplier Network Portal**.

## Business Analytics Enhancements **Updated!**

Business Analytics Dashboards use Looker to explore data and create reports. Looker is a third-party visualization and data program that is run within JAGGAER ONE. These updates have been made to the Business Analytics Dashboards in the 21.1 release:

- The field selection panel (i.e., the field picker) on the Explore pages has been updated with a new look. A new **In Use** tab shows Explore fields that are currently in use. New **search** options show popular fields and their descriptions, plus options for adding fields in the search results to Explore tables.

- A new **Quick Start** option in the Explore pages provides report examples and recommendations that can be used as starting point to run and build analyses. For those who create new reports in the interface, this makes it easier to begin building reports.

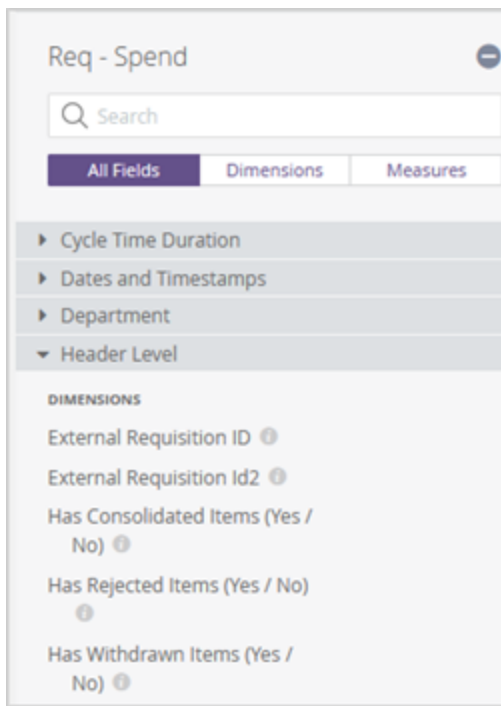

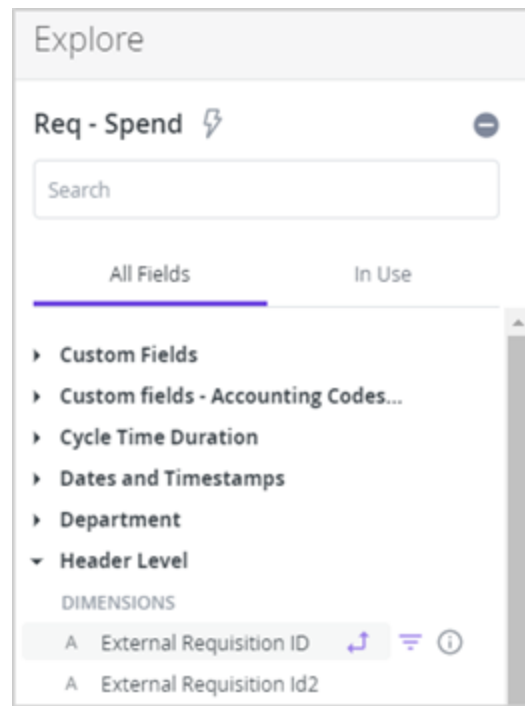
### Field Picker Changes

The field picker on the Explore pages has been updated with a new look.

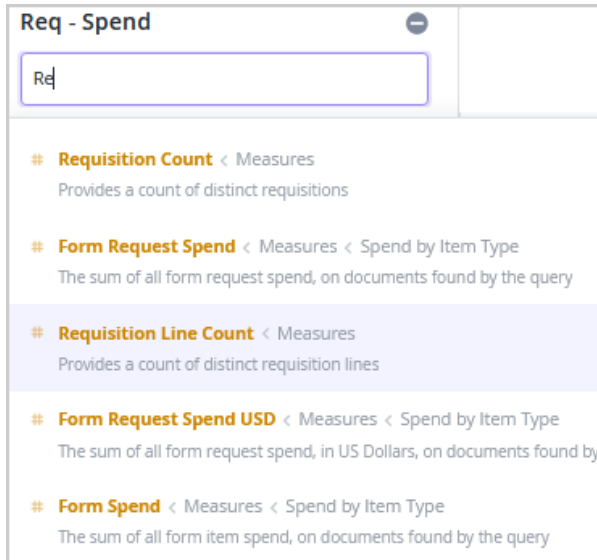

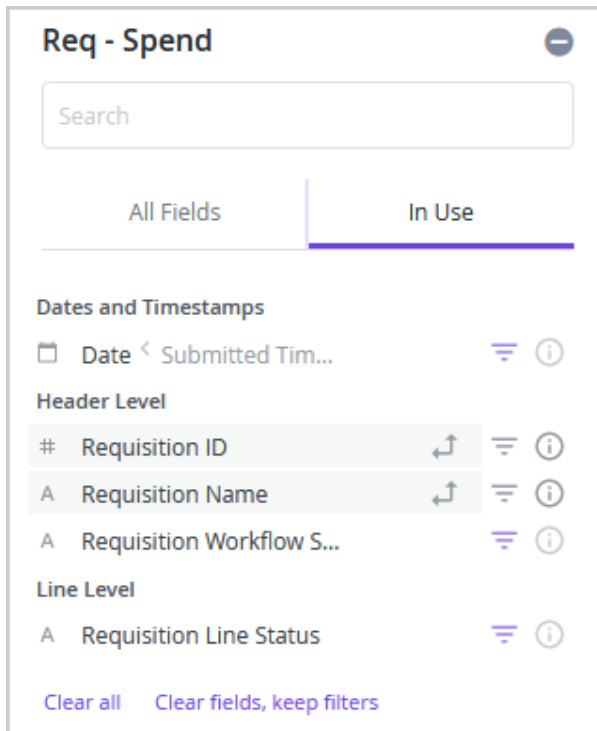


New

A new **search** field in the panel returns results weighed by popularity and by whether field names, types, data types, or descriptions match a search string. Clicking in a blank search bar displays a list of popular fields to choose from.



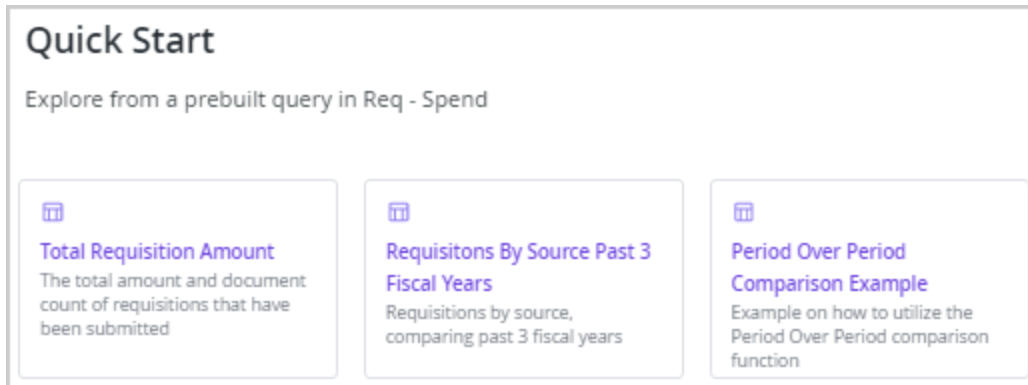
The **In Use** tab shows all fields that are currently active in an Explore, organized alphanumerically by view or view label. The icons next to each field indicate whether it is a dimension or measure, and the field's current and potential functions in an Explore query.
